SOAR Affiliate Agreement

SOAR welcomes Affiliates as cooperating rescue individuals in states other than Indiana, Ohio, and Michigan, our core states. An Affiliate is any individual who wishes to work with us in rescuing Airedales in need in their state and who agrees to the following conditions:

1. The Affiliate must complete a SOAR volunteer agreement.
2. The Affiliate must be willing to work with any SOAR volunteer and any other SOAR Affiliate while working to rescue, care for, transport, and/or place an Airedale.
3. The Affiliate must agree that, if an Airedale is to be advertised on the SOAR website, then the dog will need to be part of SOAR's inventory. A SOAR Rescue Release for owner surrenders or shelter paperwork will need to be sent to SOAR prior to advertisement.
4. If an Airedale is part of SOAR's inventory (per item #3), it is understood that, it will be microchipped and registered to SOAR, and any adoption donation for that Airedale will be made to SOAR.
5. SOAR paperwork will be used to complete adoptions or foster placements for any Airedale that is part of SOAR's inventory (per item #3). Paperwork for placements or foster placements will be sent to SOAR promptly after the placement.
6. The Affiliate must agree that SOAR will provide funds for helping with their efforts to rescue Airedales ONLY in two situations:
 - a. The Airedale is part of SOAR's inventory (per item #3) and the adoption donation for the Airedale will go to SOAR (per item #4)
 - b. The rescue Airedale is not part of SOAR's inventory but is eligible for funds from either the Diana Muldaur fund or the Cindi Mysyk fund, in which case the Affiliate may apply for money as an individual from one of these funds.

In return, SOAR will:

7. Allow the Affiliate to be listed on the National Airedale Rescue website as a SOAR Affiliate, assuming that they satisfy all other criteria for being listed on the NAR site.
8. Allow the Affiliate to be listed on the SOAR website as a SOAR affiliate on our contact page.
9. Allow the Affiliate to list their Airedales on the SOAR website as long as the conditions in item #3 are met.
10. Allow the Affiliate (if qualified) to list their name as a contact on bios posted on the SOAR website for their Airedales.
11. Provide as much volunteer help as possible to the Affiliate in rescuing, caring for, transporting, and placing an Airedale.
12. Allow the Affiliate to apply for funds from the Diana Muldaur and Cindi Mysyk funds as individuals when a rescue Airedale satisfies the eligibility criteria for these funds, but is not part of the SOAR inventory as outlined in items #3, #4 and #5. Any Airedales that are a part of SOAR's inventory are automatically eligible as long as they meet the specific criteria for the fund in question.
